DISCLOSURE INFORMATION ABOUT THE INTERVAL INTERNATIONAL EXCHANGE PROGRAM FOR MEMBERS OF THE DISNEY VACATION CLUB®

This guide (“Guide”) is provided to explain the Exchange Program made available to members of the Disney Vacation Club® (“Club”) by Disney Vacation Club Management, LLC, through its corporate participation in the Exchange Program operated by Interval International, Inc. (“II”). You should review this information to ensure that you understand the terms and conditions of participation in the Exchange Program. You should read this document prior to your registration with the Exchange Program.

DEFINITIONS

The following are definitions of special terms that are included within the text of this Guide.

1. **“Confirmation”** means a written or electronic acknowledgment from II that a request for accommodations has been fulfilled.
2. **“DVC Documents”** means the documents establishing and governing the Club and each DVC Resort, as such documents exist from time to time.
3. **“DVCM”** means Disney Vacation Club Management, LLC, a Florida limited liability company, or Disney Vacation Club Hawaii Management Company, LLC, a Florida limited liability company, as applicable, along with their legal representatives and successors and assigns.
4. **“DVC Member”** means the owner or holder of an ownership interest at a DVC Resort. DVC Members are eligible to participate in the Exchange Program if they are in good standing with DVD, DVCM, and the Club including being current in the payment of all fees and assessments prescribed by DVCM and in compliance with all DVC Documents and DVD financing documents terms and conditions then in effect. By participating in the Exchange Program, DVC Members agree to be bound by the Terms and Conditions as amended from time to time.
5. **“DVC Points”** refers to the number of Home Resort Vacation Points, as defined in the DVC Documents, necessary to reserve an accommodation at a DVC Resort by a DVC Member and expresses the DVC Member’s relative ability to request Host Accommodations in accordance with the Terms and Conditions.
6. **“DVC Resort”** means a vacation ownership resort property included as part of the Club.
7. **“DVD”** means Disney Vacation Development, Inc., a Florida corporation, along with its legal representatives and successors and assigns.
8. **“Exchange Fee”** means any fee that may be charged for exchanges made through any of the programs made available to DVC Members or Interval Members.
9. **“Exchange Program”** means the exchange program operated by II through which DVC Members obtain access to Host Accommodations.
10. **“Guest Certificate”** means a certificate provided by II allowing the use of a Confirmation by a person other than the DVC Member to whom the Confirmation was issued. Guest Certificates are provided to DVC Members at no cost to the DVC Member. Guest Certificates cannot be used by DVC Members for nonpersonal, commercial purposes.
11. **“Host Resort”** or **“Host Accommodations”** means the Member Resort into which the DVC Member has been issued a Confirmation (including Flexchange®, ShortStay Exchange®, and Getaway Confirmations).
12. **“Interval Gold®”** refers to the customized upgraded benefits package available to DVC Members in good standing. Interval Gold status provides DVC Members with select travel and leisure benefits not available through basic membership in the Exchange Program.
13. **“Interval Member”** means any person, persons, or entity who owns a vacation interest at one or more vacation ownership resorts or vacation club membership program included within the Exchange Program, who, by participating in the Exchange Program, agrees to be bound by the terms and conditions of II membership and exchange as amended from time to time. The term “Interval Member” does not include DVC Members.
14. **“Member Resort”** means any vacation ownership resort or vacation club membership program, for which a developer, homeowners’ association, or other third party has entered into a contract with II, pursuant to which accommodations and facilities may be made available to Interval Members and DVC Members, as well as any resort for which II provides exchange services directly to its owners or members. The term “Member Resorts” includes the Club and the DVC Resorts.
15. **“ShortStay Exchange”** means that exchange service offered by II to Interval Members and DVC Members participating in II’s upgraded membership tiers, including, the Interval Gold membership program, through which the Interval Member or DVC Member can be confirmed to resort accommodations for periods of less than seven (7) days.
16. **“TDI”** or **“Travel Demand Index”** means the seasonal indices that are updated periodically to reflect the cycles of relative weekly demand for a specific geographic area. TDI is a vacation-planning tool offered by II to assist Interval Members and DVC Members in determining which time periods offer the best opportunities for travel to a particular region, and when accommodations are most likely to be available. TDI is not an indication of the quality or desirability of vacationing in any specific resort, geographic area, or season, nor are they necessarily an indication of the availability of a particular week in the Exchange Program.
17. **“Terms and Conditions”** means the terms and conditions of the Exchange Program as set forth in this Guide, as it may be amended from time to time.

DVC Members should consult the DVC Documents for further information, details, and explanations of the reservation and use of the DVC Resorts and facilities, and for other terms, conditions, and information regarding their membership in DVC. II is not responsible for fulfilling any such terms and conditions, nor does II have any control over such terms and conditions as such have been established by DVD and DVCM, in their sole discretion, and are subject to change by them in their sole discretion.

THE TERMS AND CONDITIONS ARE DIFFERENT FROM II'S STANDARD TERMS AND CONDITIONS OF INDIVIDUAL MEMBERSHIP AND EXCHANGE FOR INTERVAL MEMBERS AND HAVE BEEN MODIFIED FOR THE BENEFIT OF DVC MEMBERS. THE TERMS AND CONDITIONS HAVE BEEN SPECIALLY AGREED UPON AMONG DVD, DVCM, AND II AS THEY RELATE TO DVC MEMBERS OBTAINING RESORT ACCOMMODATIONS THROUGH THE EXCHANGE PROGRAM. THEREFORE, WHEN PLACING A REQUEST FOR ACCOMMODATIONS WITH II, YOU SHOULD REFER TO THIS GUIDE AND NOT THE STANDARD TERMS AND CONDITIONS. IN THE EVENT OF A CONFLICT BETWEEN THIS GUIDE AND THE STANDARD TERMS AND CONDITIONS, THIS GUIDE SHALL PREVAIL.

WHO WE ARE

1. II is a Florida corporation offering an exchange service for use by Interval Members and DVC Members. II's parent company, Interval Holdings, Inc., is an indirect subsidiary of Marriott Vacations Worldwide Corporation ("MVW"), a Delaware corporation.

II's corporate headquarters are located at:

The obligations of II, pursuant to this Guide, may be performed by II, its authorized representatives, or designated licensees.

2. No developer of any Member Resort, including DVD, is an agent for or a joint venturer with II. II does not sell, lease, or otherwise convey an interest in any real property or other form of vacation ownership. Other than compensation and benefits that may be received by officers and directors of II from II's parent company, neither II, nor any of its officers or directors, has any direct, legal, or beneficial interest in any developer or seller of any Member Resort, including DVD. Related companies of II develop, own, and manage certain Member Resorts as follows: Marriott Ownership Resorts, Inc., and its affiliates develop, own, and manage a program currently known as Marriott Vacation Club Destinations, as well as individual resorts and programs under the brand names Marriott Vacation Club® and Grand Residences by Marriott®; HV Global Group, Inc., and its affiliates develop, own, and manage programs currently known as the Hyatt Residence Club and the Hyatt Residence Club Portfolio; Vistana® Signature Experiences, Inc., and its affiliates develop, own, and manage a program currently known as the

Vistana Signature Network®, which comprises resorts under the Sheraton and Westin brands; and WHV Resort Group, Inc. (formerly known as Welk Resort Group, Inc.), and its affiliates develop, own, and manage a program currently known as the Hyatt Vacation Club Platinum Program and individual resorts that participate as Member Resorts. Each of the foregoing related companies may develop, own, and manage other programs or individual resorts in the future. A related company of II, Aqua-Aston Hospitality, LLC, may from time to time make available accommodations for use in the Getaway program.

3. The following are the corporate officers and directors of II:

4. DVD, DVCM, and II entered into a contract pursuant to which, among other things, II will provide the Exchange Program for use by DVC Members in accordance with the Terms and Conditions.

MEMBERSHIP

1. DVCM maintains a corporate membership in the Exchange Program, and each DVC Member derives II membership benefits and exchange privileges through such corporate membership. DVCM registers each DVC Member in the Exchange Program on an annual basis during the term of the agreement and also provides each DVC Member with a one-year participation in the Interval Gold membership program. Participation in the Exchange Program commences upon II's receipt and processing of the registration form from DVCM.
2. In subsequent years, DVCM arranges for renewal of the registration of DVC Members in the Exchange Program and the Interval Gold membership program. At all times, participation in the Exchange Program and the Interval Gold membership program by DVC Members is voluntary.
3. Membership benefits including, but not limited to, participation in the exchange privilege, and other special exchange services, as mutually agreed among II, DVD, and DVCM, will be provided so long as the DVC Member, DVC, and the DVC Resorts are in good standing with II. Additionally, the DVC Member must be in good standing with DVD, DVCM, and the Club (e.g., the DVC Member is current in all payments to DVD, DVCM, and the DVC Resort, as may be applicable). Membership benefits other than the exchange privilege, including certain Interval Gold benefits,

are subject to separate terms and conditions. Said benefits, their providers, and their terms of use may be changed, substituted, or eliminated without prior notice. DVC Members are not required to utilize the exchange benefit or to use any other benefits provided through the Exchange Program.

4. Participation in II is conditioned upon the continued adherence of the DVC Resorts to II's standards of service, appearance, management, and operation. The failure of the DVC Resorts to maintain these standards or to timely renovate or construct vacation accommodations and/or amenities participating in, or committed to participate in, the Exchange Program, or the failure of the Club or the DVC Resorts to remain in good standing with II (e.g., failure to comply with contractual obligations, including the obligation to register purchasers and remit fees, the failure to honor Confirmations, and/or the failure to otherwise comply with II policies and procedures), may result in suspension or termination of the Club's or the DVC Resorts' affiliation with II. Such suspension or termination from the Exchange Program may result in the loss of all or some of the membership benefits, including the exchange privilege for DVC Members.
5. Representations concerning the Exchange Program are limited to materials supplied or otherwise approved by II in writing. All other representations are not valid or binding on II. Neither II nor any of its related companies are authorized to make promises binding on any of the others, and each entity will only be responsible for the representations made in its own written materials, or by its own employees or authorized representatives.
6. II uses all reasonable efforts to ensure that information provided in II's materials is accurate. II, however, expressly disclaims liability in the event of omission or error.
7. Interval Members and DVC Members acknowledge that:
 - (a) Resort facilities, amenities, and services vary by country, location, and resort, and room accommodations vary in size, decor, and interior detail.
 - (b) The description and amenities symbols provided in II's materials, like its online directory, for each Member Resort are representative of the features generally available at such Member Resort. However, unit amenities and views may vary from unit to unit within a Member Resort, and II cannot guarantee specific selection of any such elements with respect to the Host Accommodations, or that all amenities will be available during any specific period of occupancy. Each DVC Member should review the Confirmation for specific information about his or her Host Accommodations.
 - (c) The exchange privilege should not be the primary reason for purchasing a vacation interest, and the relative demand indicated in a Travel Demand Index and assigned to each particular week should not be relied upon in determining the value of any week for exchange.
 - (d) II and its related companies are not liable for any damage to, or loss or theft of personal property left in DVC Resort accommodations; nor is II or any of its related companies liable for any damage to, or loss or theft of personal property that occurs through an Interval Member's or DVC Member's use of Host Resort accommodations. II and its related companies are not liable for any death, illness, or personal or bodily injury that occurs either at a DVC Resort or at a Host Resort.
 - (e) II is not liable or responsible for any claim or loss incurred in connection with the purchase or ownership of an ownership interest, or your participation, in the Club.
 - (f) Upon each use of the Exchange Program, and to the extent allowed by applicable law, any and all claims against II and its related companies are waived, and II and its related companies are released from all liability, if any, arising out of an Interval Member's or DVC Member's participation in the Exchange Program and/or any of its benefits and services that may have accrued prior to such use.
 - (g) II's liability and that of its related companies, if any, to a DVC Member in connection with participation in the Exchange Program and/or any of its benefits and services, is limited to the Exchange Fees and other fees paid to II by or on behalf of that particular DVC Member.
 - (h) II and its related companies make no warranty, express or implied, as to the condition, capacity, performance, or any other aspect of the activities, events, or providers associated with the benefits or services made available to Interval Member and DVC Members in connection with their participation in the Exchange Program and/or in benefits and services ancillary thereto. No inquiry has been made into such activities or events, or into the qualifications or the quality of services offered by such providers, and the offering of their benefits and services does not constitute an endorsement of or recommendation for any of such benefits or services by II or any of its related companies. Each Interval Member and DVC Member releases II and its related companies and waives his or her rights against each such party for any personal or bodily injury, death, or illness that occurs during or related to such Interval Member's or DVC Member's participation in such benefits or services.
 - (i) All rules and regulations of the Host Resort, as well as the Terms and Conditions, must be adhered to. Violation of such rules or the Terms and Conditions may result in the loss of present and future occupancy rights at the Host Resort, and/or the cancellation of participation in the Exchange Program without further obligation by II.
 - (j) If a membership in the Club is owned by a corporation, partnership, or trust, a corporate officer, partner, or trustee must be established as the primary contact or administrator to manage the membership.
 - (k) Where multiple individuals are listed in a single DVC Member record as the owners of an ownership interest in DVC, one individual and such individual's contact information must be

- designated as the primary contact to whom all Exchange Program membership materials, Confirmations, and other permitted communications will be sent. Contact information may also be included for all other owners. II will continue to provide benefits for all individuals listed until II receives verifiable documentation of any change of ownership of the DVC ownership interest.
- (l) Participation in the Exchange Program and use of other benefits made available through II may be used only for personal and noncommercial purposes. Any other use of benefits may result in the suspension or termination of an Interval Member's or DVC Member's privileges, as well as cancellation of any existing Confirmations and loss of any fees.
- (m) II may, at its sole discretion, suspend or terminate participation where the DVC Member uses inappropriate, abusive, or discriminatory behavior in his or her interactions with any Interval Member or any employee of II or its Member Resorts, or otherwise in his or her use of II's Community web forum or in other social media channels.
- (n) To the extent allowed by applicable law, phone conversations between DVC Members and II employees or representatives may be recorded and/or monitored.
- (o) If II should fail or be delayed or impaired in the performance of any obligation hereunder, including, but not limited to, providing exchange accommodations, due to causes beyond the reasonable control of and without the fault or negligence of II (a "Force Majeure Event"), then II shall be excused from further performance for the duration of the Force Majeure Event. Force Majeure Events may include, but are not limited to, acts of God or public enemy, fire, strikes, lockout or other labor unrest, riot, explosion, civil disobedience, declared or undeclared war, revolution, insurrection, boycotts, acts of piracy, acts of terrorism, acts of public authorities, blockade, embargo, accident, pandemic, epidemic, quarantine, labor shortages based on pandemics or widespread illness within a given servicing location, delays or defaults caused by public or common carriers, and/or other circumstances materially impacting travel to a particular region or in general.
- (p) Although II submits this Guide for approval by regulatory agencies having jurisdiction over timeshare and exchange programs in various states, such approval should not be interpreted as applying to any travel, leisure, or other benefit or service falling outside the jurisdiction of any such agency.
- (q) II is prohibited from doing business with certain entities and individuals residing in certain nationally sanctioned countries or otherwise as set forth from time to time on any list maintained by the U.S. Department of the Treasury's Office of Foreign Assets Control (collectively, "Blocked Parties"). If II receives a registration form for a purchaser defined as a Blocked Party, II will refuse participation for such purchaser. If a DVC Member subsequently becomes or is determined to be a Blocked Party, II will cancel participation without refund or other obligation.
- (r) Use of any automated system, scripting, or any other method by a DVC Member to secure services from II, including confirming an exchange or purchasing a Getaway, is prohibited. II reserves the right, at its sole discretion, to cancel the Confirmation(s) of any individual it suspects to be the result of tampering with the operation of the disney.intervalworld.com website, or otherwise in violation of II's terms and conditions. Such actions may also result in the suspension or termination of a DVC Member's participation in the Exchange Program or other benefits.
8. DVC Members acknowledge and agree to the terms of the II Privacy Policy, which Privacy Policy is available for review on II's website, disney.intervalworld.com. The sharing of a DVC Member's personal information, including contact details, to select third parties, such as resorts, owners' associations, travel and service providers, and other suppliers is solely for the purpose of facilitating the Exchange Program and as necessary for II to verify details relating to such DVC Member's standing with the Exchange Program and/or with the Club and/or to provide the products, benefits, and services made available to the DVC Member pursuant to this Guide. II will not use a DVC Member's personal information for marketing, selling, or commercial purposes, except as agreed among DVD, DVCM, and II.
9. The Terms and Conditions and the use of the Exchange Program shall be construed under the laws of the State of Florida. By participating in the Exchange Program, DVC Members consent to the exclusive subject matter and personal jurisdiction of the courts in Miami-Dade County, Florida. In the event of litigation between the parties, the substantially prevailing party shall be entitled to all costs incurred, including reasonable attorneys' fees.
10. The Terms and Conditions, including any fees associated therewith, may be changed by II at its sole discretion. Except where expressly noted otherwise, DVC Members will be advised of any such changes through the Club's regular publications or on the Club website or on II's website, disney.intervalworld.com.

SPECIFIC PROCESSES FOR POINTS-BASED EXCHANGE

1. Exchange Methods. Generally, DVC Members may choose either the Request First or the Deposit First exchange method to utilize the exchange service.
2. DVC Members trading with the Exchange Program based on the relinquishment of DVC Points may utilize an exchange method, referred to as Request First, whereby they do not give up their DVC Points until an exchange has been confirmed.
3. Under the Deposit First exchange method, a DVC Member may deposit DVC Points with II. Once the DVC Points are deposited with II by the DVC Member, the DVC Points will remain with II until used by the DVC Member for an exchange or the expiration date for the DVC Points, whichever occurs first. The DVC Points will not be returned to the DVC Member.

4. Deposits must be received by II at least 45 days, but no more than 24 months, before the expiration date of the DVC Points.
5. Upon receipt of a deposit, II will assign a deposit number, which must be utilized when placing an exchange request. Except for the flexible lengths of stay provided under II's ShortStay Exchange service, as is described below, an exchange may be requested for the same amount of time as that deposited. The exchange request may be placed at the same time that the deposit is made or no later than the expiration date of the DVC Points. All standard exchange procedures (as detailed below) must be adhered to when placing a request against the deposited points.
6. DVC Points
 - (a) For a Confirmation to be issued, DVC Members must relinquish the required number of DVC Vacation Points.

DVC Members should refer to the Interval International Point Chart for DVC Members on the left to determine the number of DVC Points currently required for a requested exchange accommodation. When an exchange request is placed, the DVC Points required for the highest-valued accommodations requested are placed on hold by DVCM and, accordingly, will not be available for use during the pendency of such exchange request.

- (b) Once a Confirmation has been issued, the DVC Member will be deemed to have used the number of his or her DVC Points applicable to such Confirmation, and such DVC Points will no longer be available to that DVC Member, unless the Confirmation is canceled in accordance with the II Exchange Cancellation Policy for DVC Members, as described in General Exchange Procedures and Priorities, Paragraph 13 of this Guide.
 - (c) Where a given exchange request is not confirmed or a Confirmation is canceled in accordance with the II Exchange Cancellation Policy for DVC Members, as stated below, the DVC Points will be released back to the DVC Member's account with DVC or II, as is applicable.
 - (d) DVC Members may relinquish their DVC Vacation Points for a future exchange request in a subsequent year. DVC Members may request the future exchange by contacting DVC Member Services no later than December 31 of the second calendar year following the calendar year in which the DVC Points were relinquished. For example, if a DVC Member relinquishes his or her DVC Points for a future exchange request in a subsequent year on April 30, 2023, such exchange right would remain available for use in the Exchange Program until its expiration on December 31, 2025. Once the DVC Points have been relinquished for a future exchange request, they cannot be returned to the DVC Member's DVC Points account.
7. II is the exclusive external exchange provider for DVC Members; e.g., it has the exclusive right to provide exchange services and issue Confirmations for DVC Members exchanging from one Member Resort to another or otherwise pursuant to this Guide. All other communications to DVC Members are handled by DVC Member Services, it being understood that all such transactions will be conducted by DVCM in accordance with rules and processes established by DVCM, in its sole discretion.

GENERAL EXCHANGE PROCEDURES AND PRIORITIES

1. To utilize the exchange privileges pursuant to the Terms and Conditions, including special exchange services, the DVC Member must be in good standing with II, DVD, DVCM, and the Club from the time a request is placed through the actual travel dates. In addition, DVD, DVCM, the Club, and the DVC Resorts must be in good standing with II.
2. To place a request for exchange accommodations, a DVC Member must contact DVC Member Services directly where a Cast Member assigned to assist DVC Members in securing

- exchanges through the Exchange Program will process the DVC Member's exchange request. Alternatively, the DVC Member may request and secure an exchange directly online by accessing II's website by clicking through the link on the Club website, disneyvacationclub.disney.go.com. In either instance, the exchange through II will be based on the relinquishment of DVC Points by or on behalf of the applicable DVC Member. DVC Points will be deducted from the DVC Member's account in accordance with Interval International Point Chart for DVC Members, the current version of which is featured in Paragraph 3 of the preceding section, based upon the unit size and relative demand of the Host Accommodations confirmed.
3. To submit a valid exchange request, a minimum of three different resorts and one time period, three different time periods and one resort, or two resorts and two time periods must be requested. DVC Members may be automatically confirmed into any of the resorts or time periods requested.
 4. Regular exchange requests must be made at least 60 days in advance of the commencement date of the week requested.
 5. Flexchange is a service in which vacation exchange requests may be submitted from 59 days up until 24 hours in advance of the travel dates desired. Available Host Accommodations for the date requested will be offered, and an instant Confirmation will be issued if one of the availabilities offered at the time of the call is accepted. Holiday, summer, and other highly demanded weeks usually are not available through this late-request exchange service. All other Terms and Conditions apply to this service, except where expressly noted to the contrary.
 6. A Confirmation will not be issued until the availability of the required number of DVC Points is verified.
 7. Once an exchange request is submitted, it may be withdrawn only if notice of withdrawal is received by II prior to Confirmation of the request. Once issued, a Confirmation may be canceled only in accordance with the II Exchange Cancellation Policy for DVC Members, as described in Paragraph 13 of this section.
 8. To participate in a ShortStay Exchange, a DVC Member must be a participant in the Interval Gold membership program. Holiday, summer, and other highly demanded travel periods usually will not be available through ShortStay Exchange. All Terms and Conditions, including II's Exchange Cancellation Policy for DVC Members, apply to this exchange service, except as noted to the contrary.
 9. While an Exchange Fee is required to be paid to II by Interval Members generally when an exchange request is placed, DVCM has currently agreed to pay Exchange Fees on behalf of DVC Members with the exception of exchange requests through the Hotel Exchange Program.
 10. Exchanges are arranged on a space-available basis. Neither II, DVD, DVCM, nor any developer or marketer can guarantee the fulfillment of a specific request, as weeks are received on a periodic basis throughout the year. II does not control the timing, location, or number of weeks made available to the Exchange Program for exchange.
11. DVC Members may confirm as many exchanges as their DVC Points will support.
 12. Only II can issue Confirmations for exchange requests, and only II Confirmations are valid. II will attempt to confirm a request until 48 hours before the latest travel dates requested; however, beginning on the 29th day prior to the latest travel dates requested, the DVC Member will be contacted by phone in order to obtain acceptance (or rejection) by the DVC Member prior to issuing a Confirmation.
 13. II Exchange Cancellation Policy for DVC Members
 - (a) Under this policy, a DVC Member may be entitled to cancel any Confirmation issued seven (7) days or more in advance of the first date of occupancy of the Host Accommodations; however, in all instances, the DVC Member through the applicable DVC Cast Member must notify II of his or her desire to cancel such Confirmation seven (7) days or more in advance of the Host Accommodations' initial date of occupancy. Upon cancellation of the qualified Confirmation, the DVC Member's DVC Points will not be returned to the DVC Member, but the DVC Member will have the right to request a future use in the Exchange Program until December 31 of the second calendar year following the calendar year in which the DVC Member's Confirmation was canceled. For example, if a DVC Member (or the applicable Cast Member) cancels an eligible Confirmation on April 13, 2023, the DVC Points will not be returned to the DVC Member, but the DVC Member will have the right to request an exchange through the Exchange Program until December 31, 2025.
 - (b) Notwithstanding the foregoing, a DVC Member may not cancel any Confirmation after the exchange request is initially confirmed if such cancellation occurs as a result of the Host Accommodations being damaged or destroyed, or where such damage or destruction could be reasonably anticipated due to circumstances such as an approaching weather event, flood, or fire.
 - (c) In all other circumstances, Confirmations issued to a DVC Member are considered noncancelable and any attempt to cancel a Confirmation will result in the loss of the DVC Member's DVC Points without the use of Host Accommodations.
 - (d) II's Exchange Cancellation Policy does not apply to Confirmation issued through the Hotel Exchange Program. Such cancellations will be handled in accordance with Paragraph 5 of the Special Exchange Services section.
 14. DVC Members may be confirmed into a Host Resort with weekly time periods beginning on any day of the week.
 15. Priority in the exchange Confirmation process is established as follows:
 - (a) Interval Members may be afforded a priority when requesting an exchange to Member Resorts that are owned, or in

certain instances, branded, marketed, and/or managed, in common with such Interval Member's home resort.

- (b) Interval Members who own a vacation interest at a Member Resort located in certain geographic regions including, but not limited to, Australia, New Zealand, and/or South Africa, and are requesting an exchange to other Member Resorts that are located in the same geographic region as the Interval Member's home resort may receive a priority right to receive an exchange Confirmation in such region.
- (c) It does not issue Confirmations for (i) an exchange into any DVC Resort located in the Orlando/Kissimmee, Florida, area to any Interval Member who owns a week-specific interest in a Member Resort located within the Orlando/Kissimmee, Florida, area; (ii) an exchange into a Member Resort located in the Orlando/Kissimmee, Florida, area to a DVC Member owning a week-specific interest in a DVC Resort located in the Orlando/Kissimmee, Florida, area; or (iii) an exchange by a DVC Member to any DVC Resort, it being understood that all such transactions will be conducted by DVCM or its third-party internal exchange provider in accordance with rules and processes established by DVCM, in its sole discretion.
16. Confirmations and their associated Host Accommodations, including, without limitation, those made available through the Getaway program, may be used only for personal and noncommercial purposes. DVC Members are expressly prohibited from exchanging or renting the Host Accommodations, including, but not limited to, offering the Host Accommodations for sale or rent to third parties through the use of a Guest Certificate or otherwise. Failure to use the Host Accommodations will not entitle the DVC Member to recover the DVC Points relinquished to secure the applicable Confirmation.
17. Confirmations are issued only in the name of the DVC Member authorized to place the exchange request, and Host Accommodations may be used only by the DVC Member to whom the Confirmation is issued and accompanying guests, unless a Guest Certificate is obtained from It. It provides Guest Certificates to DVC Members at no additional cost. Guest Certificates may only be obtained for personal or noncommercial purposes. Failure to secure a Guest Certificate where required for a guest of a DVC Member when the DVC Member does not plan to occupy the Host Accommodations (including, those instances where the DVC Member has been issued Confirmations for multiple accommodations having the same travel dates at the same Host Resort) or obtaining Guest Certificates that are used for commercial purposes may result in the termination of participation in the Exchange Program and cancellation of any existing Confirmations, including those with future travel dates. Guests of DVC Members who arrive at a Host Resort without a Guest Certificate will be denied access to the accommodations until the DVC Member has obtained a Guest Certificate from It.
18. The DVC Member requesting the Guest Certificate is responsible for the acts and omissions of the individuals occupying the Host Accommodations, including any loss or damage to the Host Accommodations.
19. Individuals under the age of 21 are not eligible to receive a Guest Certificate. Additionally, the issuance of a Guest Certificate and the use of the Host Accommodations are subject to any restrictions or limitations that may be imposed by the Host Resort.
20. DVC Members are expressly prohibited from selling or exchanging a Guest Certificate for cash, barter, or other consideration. In the event that any of the above terms are breached, It reserves the right to revoke the Guest Certificate, cancel the underlying Confirmation, and terminate participation in the Exchange Program without further obligation by It.
21. By submitting an exchange request, DVC Members represent and warrant that they have the right to use and relinquish the use and occupancy of their DVC Points, and that all required payments, maintenance fees, taxes, or similar charges have been paid through the requested travel dates. Exchange privileges may be denied if all such payments with DVD, DVCM, or the Club have not been paid. It reserves the right to cancel any previously issued Confirmation if it subsequently receives notice that a DVC Member is not in good standing with DVD, DVCM, or the Club.
22. It reserves the right to limit the number of Confirmations, including, without limitation, those made as part of the Getaway program, issued to a particular DVC Member in any particular year, and to limit the number of accommodations confirmed to a DVC Member for any given Member Resort or for any given travel dates.

SPECIAL EXCHANGE SERVICES

1. The Getaway program is a special exchange service offered by It from time to time in which resort accommodations are confirmed to Interval Members and DVC Members upon payment of a fee, plus any applicable tax. The resort accommodations available through the Getaway program include resort accommodations that have been deposited or relinquished by or on the behalf of Interval Members, but are not otherwise utilized by It, and resort accommodations made available to It directly by resort developers or other third parties. Accommodations at DVC Resorts are not available through the Getaway program.
2. The fee charged to DVC Members by It is based primarily upon the unit size confirmed, the location of the accommodations, the occupancy date, and the length of stay. Getaway Confirmations cannot be used for nonpersonal, commercial purposes, such as resale to third parties.
3. It's Exchange Cancellation Policy does not apply to Getaway Confirmations. Any cancellation of a Getaway Confirmation results in the loss of the Getaway resort accommodations and all fees paid. Getaway fees will not be refunded under any circumstances.
4. (a) The Hotel Exchange Program is available to DVC Members in good standing with the Interval Gold membership program

- as an alternative exchange service offered by II, whereby DVC Members are allowed to secure Confirmations based on the relinquishment of DVC Points as a credit against the reservation of hotel accommodations participating in the Hotel Exchange Program.
- (b) To secure a Hotel Exchange Confirmation, the DVC Member must relinquish a minimum of twenty (20) DVC Points, although the actual number of DVC Points required to secure a Hotel Exchange Confirmation will be determined on many factors, including the number of nights confirmed, hotel selected, room type, and travel dates.
 - (c) For all Hotel Exchange Confirmations, an Exchange Fee, as designated by II at the time the request is placed, shall be paid by the applicable DVC Member. The Exchange Fee associated with an exchange request made under the Hotel Exchange Program will be returned only if an exchange cannot be confirmed and cancellation of the applicable exchange request is received by II prior to Confirmation. Once a Confirmation is issued under the Hotel Exchange Program, the Exchange Fee paid is nonrefundable.
 - (d) A payment, in addition to the DVC Points relinquished and the Exchange Fee, may be required and must be paid at the time of Confirmation. This additional payment will be based on many factors, including the number of nights confirmed, hotel selected, room type, and travel dates.
 - (e) Promotional or discount coupons may not be applied toward hotel accommodations confirmed through the Hotel Exchange Program.
 - (f) Under the Hotel Exchange Program, the hotel exchange booking date must be at least three (3) days prior to the check-in date, but no later than any advanced booking date requirement of the desired hotel or resort.
5. II's Exchange Cancellation Policy does not apply to Hotel Exchange Confirmations. Any cancellation of a Hotel Exchange Confirmation will be addressed in accordance with this Paragraph 5. Hotel Exchange Confirmations will be subject to the cancellation policy stated in the booking process for the specific hotel accommodations. DVC Points relinquished toward a Hotel Exchange Confirmation will be returned to the applicable DVC Member's account only if the cancellation policy of the applicable hotel accommodations provider(s) allows for the cancellation of the Confirmation under the circumstances relevant to the Hotel Exchange Confirmation's cancellation. Also, in the event of a cancellation of a Hotel Exchange Confirmation, the additional fee paid in conjunction with such Confirmation will be refunded in accordance with the refund policies of the provider(s) of the hotel accommodations, which may result in the DVC Member receiving no refund, or only a partial or prorated refund, of this additional fee. In all instances, once a Hotel Exchange Confirmation is issued, the Exchange Fee paid for such Confirmation is nonrefundable.
 6. If, after a Hotel Exchange Confirmation is issued, it is determined that the applicable DVC Member is not in good standing as stated in the Terms and Conditions, the DVC Member will be required to pay the entire amount due for the hotel accommodations (without offset for the value of the DVC Points relinquished to secure such accommodations), or will be subject to the cancellation policy for the specific hotel, which may include payment of a cancellation penalty.
 7. For all Hotel Exchange Confirmations, if the number of the DVC Points required to be relinquished to obtain the Hotel Exchange changes upon verification, the additional payment required to be made by the DVC Member may be increased.
 8. Hotel Exchange Confirmations may not be sold, bartered, or exchanged for other consideration. However, where the DVC Member will not be occupying the confirmed hotel accommodations, a Guest Certificate may be obtained in accordance with the terms set forth in Paragraphs 16 and 17 under General Exchange Procedures and Priorities.
 9. All Terms and Conditions apply to Getaway or Hotel Exchange exchange services, except where noted to the contrary.

FEES

The fees set forth below are applicable for residents of the United States, Canada, and the Caribbean. Residents of other geographic areas are subject to different fees, which are assessed by local servicing offices or representatives.

1. DVCM maintains a corporate membership in the Exchange Program, and each DVC Member derives II membership benefits and exchange privileges through such corporate membership. DVCM registers each current DVC Member in good standing in the Exchange Program annually and also provides each DVC Member with a one-year membership in the Interval Gold membership program. Participation in the Exchange Program commences upon II's receipt and processing of the registration form from DVCM.
2. In subsequent years, DVCM arranges for renewal of the corporate membership in the Exchange Program and the Interval Gold membership program. At all times, participation in the Exchange Program and the Interval Gold membership program by DVC Members is voluntary.
3. Notwithstanding the provisions of the foregoing Paragraphs 1 and 2, where a DVC Member also owns a vacation interest in addition to his or her DVC vacation interest and also includes such other vacation interest in the Exchange Program, the DVC Member must maintain a separate Interval Membership in the Exchange Program in addition to his or her participation in the Exchange Program based on the corporate membership program offered through the Club.
4. DVCM is responsible to pay the Exchange Fee for DVC Members to secure exchange Confirmations through the Exchange Program, with the exception of exchange requests through the Hotel Exchange Program. For exchange requests through the Hotel Exchange Program, the applicable DVC Member will be required to pay an Exchange Fee of US\$95

at the time the exchange request is placed. The exchange fee associated with an exchange request made under the Hotel Exchange Program will be returned only if an exchange cannot be confirmed and cancellation of the applicable exchange request is received by II prior to Confirmation. Once a Confirmation is issued under the Hotel Exchange Program, the Exchange Fee paid is nonrefundable.

5. II may suspend exchange privileges in the event a DVC Member fails to pay any amount owed to DVD, DVMC, the Club, II, or the Host Resort.
6. Some jurisdictions have imposed a tax on the occupant of resort accommodations. Consequently, any bed tax, transient occupancy tax, or similar tax that is imposed shall, in those circumstances, be the responsibility of the exchanging member. DVC Members may be required to contact the Host Resort prior to arrival in order to prepay such taxes and certain other resort fees. Additionally, DVC Members are responsible for all personal charges (e.g., phone calls and meals) while at the Host Resort, and any utility surcharge or other charge imposed by a resort, as well as any damage to, or loss or theft from the Host Accommodations and its associated facilities caused by the DVC Member or their guests.
7. Fees, if any, charged by Member Resorts for certain services, meal plans, and amenities are determined and levied by each resort. Such fees are the responsibility of the applicable DVC Member. These fees vary from resort to resort.
8. All fees may be increased from time to time by II at its discretion. DVC Members will be advised of any such increases through the Club's regular publications, or on the Club's website or on II's website, disney.intervalworld.com.

Notes to Report of Key Operating Exchange Statistics

As of and for the Year Ended December 31, 2021

1. Basis of Presentation

The accompanying Report of Key Operating Exchange Statistics includes the combined exchange statistics of Interval International, Inc., including operations performed by subsidiary companies (collectively, “Interval International” or “II”) after eliminating intercompany activities for the year ended December 31, 2021. The statistics reflected in the Report of Key Operating Exchange Statistics were computed and are disclosed in conformity with Sections 721.18(1)(q) and (r) of the Florida Vacation Plan and Timesharing Act.

2. Description of Company

Interval International is a service company offering an exchange service for owners of resort timeshare or other vacation ownership interests. Resorts affiliated with II are located throughout the world. II’s world headquarters is located in South Miami, Florida.

3. Resort Affiliations

Resorts have contracted with II to provide exchange services for purchasers of their timeshare or vacation ownership interests. Included in the current number of resorts in the category of “accommodations and facilities or properties that have current affiliation agreements but are not eligible to participate with Interval International as of December 31, 2021” are those resorts which were conditionally accepted as member resorts of the Interval International exchange program or were in a suspended status as of December 31, 2021.

4. Individual Memberships

An owner’s individual membership and participation in II’s exchange program is dependent upon the owner’s resort remaining in good standing with II. An individual’s exchange privileges may be suspended during periods when the resort is not in good standing with II. Upon the payment of an annual membership fee, individual members generally receive various publications and the opportunity to exchange the use and occupancy of their vacation ownership interest for another, as well as other benefits offered by II. Individual members are considered as members for 120 days after their scheduled expiration date, although II may discontinue providing services to individuals who own vacation ownership interests at resorts participating in a corporate membership program where the resort’s developer fails to timely remit the applicable corporate membership fee. Also, where an individual owns a vacation ownership interest, both at a resort participating in a corporate membership program and a resort at which owners participate as

individual members, generally, such individual must maintain separate and distinct memberships and, for the purpose of determining the number of owners participating as members, will be counted as two members.

5. Deposits

Generally, members may choose to deposit weeks available for occupancy into the II exchange program up to two years in advance of the occupancy date. When a week is deposited into the II exchange program, the right to use said week is immediately relinquished by the member. Members depositing a vacation week may submit an exchange request and travel at any time after II's receipt of the deposit up until 24 months after the commencement date of the deposited week, unless the member has extended the redemption window applicable to a particular deposit through the payment of a fee designated by II.

During the year ended December 31, 2021, 309,851 weeks were deposited with the II exchange program by members (or on their behalf) for which the members have the right to an exchange opportunity. II's obligation to accept exchange requests against the deposited weeks ends on varying dates through 2027. II has no obligation to provide a member depositing a vacation week with exchange accommodations in a subsequent year if: (a) the member fails to submit a valid exchange request and travel within the member's available redemption window or a permitted extension thereof; (b) the requested accommodations are not available and any alternative accommodations offered by II are not accepted by the member; (c) the member cancels an issued Confirmation less than seven days prior to occupancy of the Host Accommodations or otherwise fails to comply with the requirements of II's Exchange Cancellation Policy; or (d) the use of either the deposited week or confirmed accommodations is lost or impaired due to circumstances beyond II's control.

6. Exchange Requests and Confirmations

Exchange requests must be properly submitted in accordance with II's Terms and Conditions of Individual Membership and Exchange in order to be included in this report.

Exchanges are arranged on a space available basis. II does not guarantee fulfillment of a specific request.

6. Exchange Requests and Confirmations (continued)

In order for an exchange request to be considered properly applied for, and, therefore, included in the key operating exchange statistics, the member must either fully complete a written or electronic exchange request in accordance with the instructions furnished by II and in accordance with the Terms and Conditions of Individual Membership and Exchange, or the member must provide the same information that is requested to the II vacation advisor at the time the member places a request by telephone. An exchange request may be confirmed instantly if the accommodations requested by the member are available. Otherwise, if the request is for accommodations more than 59 days in advance of the date requested, it will be entered into the proprietary exchange system as a properly applied for exchange request. The key operating exchange statistics made available in this report also include requests made and confirmations issued pursuant to the Special Exchange Services outlined in II's Terms and Conditions of Individual Membership and Exchange (i.e., II's Getaway and Interval Options Programs), as well as requests made and confirmations issued pursuant to exchange incentives periodically made available to select individual members. Confirmations reported also include properly submitted exchange requests against which exchange alternatives were offered and accepted by members.

If the member fails to complete all the required information at the time of placing a request (such as, fails to request the minimum number of resorts or time periods), or otherwise fails to adhere to II's prescribed exchange procedures, such request is not included in the key operating exchange statistics. Also, excluded from the statistics are any exchange requests made by a member, whom, based on information provided to II by the home resort, is either no longer an owner at such resort or is not currently in good standing with such resort due to nonpayment of maintenance fee assessments or similar charges.
